ORA and Ministry of Health

Welcome to our Fall 2009 newsletter. There has been a lot of activity on numerous projects at the Ontario Rheumatology Association.

One of our biggest activities has been communication with the Ministry of Health in Ontario and particularly with the Exceptional Access Program as it relates to access for biologic drugs for our patients. Members of the ORA executive have had meetings with MOH-EAP officials and talks are ongoing.

Several concrete things have emerged from these consultations. The first is the acceptance by the MOH of the ORA's rheumatoid arthritis application form. This form, now available at http:// www.rheum.ca/en/ on the ORA page, will be the submission form used by all the pharmaceutical companies and will be accepted from rheumatologists as well. It is hoped that this from will become the main submission form for all, and new forms for Ankylosing Spondylitis and Psoriatic Arthritis are also in development.

The Ministry of Health is aiming for a **2 week turnaround** time on EAP applications for biologics and it is hoped that with one form used by all, that that goal might be easier to attain.

A recent practice audit by Dr. Thorne revealed that

before using the new form, he was getting more than half the forms returned looking for further information and with a 9-12 week turnaround time. With the new form, 4 were approved in 4 weeks, and 4 in 5 weeks, with no returned for more information.

Patient Toolkit

The Ontario Biologics Registry has produced a Patient Toolkit to assist our patient in understanding the Exceptional Access Program (EAP) and how they as consumers can become more involved in their ongoing access to prescribed medications.

The document explains the

process of application to the EAP plus the Trillium drug plan. It also contains the contact information for all the biologic drug manufacturers and an explanation of how this whole process is supposed to work.

This is a great tool which will empower patient in this often difficult process and help to explain to them the rules and responsibilities of all involved parties.

OMA Update

Dr. Philip Baer continues to do an excellent job as our Ontario Medical Association section representative, enhancing the position of Rheumatology at the provincial level. Fees will increase on October 1, 2009 and will favour rheumatologists over most other groups.

In summary, consultation fees will increase 8.2%, followup fees increase 10.2% and the G382 fee code (monitor chemotherapy lab work) will increase 7.1%. We should also see new codes for certain joint and bursa aspirations The new limit on G371 joint injections will increase from 3 to 5.

Full details of these increases and more will be available soon from the OMA so watch for fax and email updates, check the OMA website and check with your billing software provider. Dr. Baer is actively working the Rheumatology section's submissions for October 2010. We are looking at increasing the number for diagnostic codes that qualify for E078 (such as vasculitis) and also for tray fees to cover the cost of supplies for joint injections/aspirations done in the office setting.
